GUIDE FOR AUTHORS 2018

INVESTIGACIÓN AGROPECUARIA journal is a biannual publication that aims to disseminate national and international research findings that impact on the agricultural sector, either directly in the production of raw materials or indirectly, in the process of rural communities development. Manuscripts must be original, in Spanish, Portuguese or English, based on research results, but is allowed the development of historical accounts based on a broad review of a particular topic.

INVESTIGACIÓN AGROPECUARIA journal publishes articles related to agricultural production and rural development in: horticulture, plant protection, crop nutrition, greenhouse management, irrigation, soil and growing media, biotechnology, plant breeding, microbiology, animal behavior, animal reproduction, animal health, animal parasitology, sociology, economics and development issues in rural areas.

To submit contributions to *INVESTIGACIÓN AGROPECUARIA* journal must be followed editorial standards presented here, as the first requirement for acceptance of documents, and then undergo a double-blind refereeing process for final acceptance

Originality

By submitting an article to the *INVESTIGACIÓN AGROPECUARIA* journal, author and co-authors (if any) attest that the contribution is ORIGINAL, which has not been published or is being considered simultaneously its publication in any other journal.

Is assumed and taken for granted, that by submitting any document to *INVESTIGACIÓN AGROPECUARIA* journal, it has the approval of all the co-authors (if any) and the authorities of the (s) institution (s) where they developed the investigation and that both, authors and institutions accept transfer to *INVESTIGACIÓN AGROPECUARIA* journal, the property rights for publication. Editorial process

Received the contribution will assess the relevance to the objectives of the journal and notify to first author. If the document meets the editorial standards will be assigned a

receipt number and notify to first author. The receipt number will serve as a key reference in the editorial process.

Arbitrage

All contributions received are sent to two academic peers (not from the institution of any of the authors) who dictate anonymously (both for authors and for peer reviewers) if the document: a) must be published exactly as it is, by its coherence, structure, organization, writing and methodology; b) may be published with minor corrections; c) may be published after substantial corrections; or d) should not be published because it does not meet the content requirements of *INVESTIGACIÓN AGROPECUARIA* journal. In case of dispute of the results, will be sent to a third adjudicator whose decision will determine the publication or not, of the contribution. If the notice does not meet the objectives of the journal editorial standards or rejection, shall be communicated to the principal author.

Once the document is assessed by the reviewers, shall be communicated to the principal author of the necessary modifications (if any), so that, at the earliest, the principal author should return the document with suggested modifications to the final approval. After receiving the corrected contribution, will be sent final acceptance letter which indicates the volume, number and the date, in which the document will be published.

Costs

Once determined the final acceptance of the contribution, will tell to the principal author how much will pay for costs of editing and publishing. Once the payment done, the voucher to the magazine's editorial coordination must be sent.

TO MANUSCRIPT PREPARATION

The original should be presented in letter size without editing or justification, double-spaced, with Arial 12 point, Word Processor 6.0 or later for Windows 98 or later. The page margin will be 2.5 cm on all four sides. All pages should be numbered consecutively. All lines should be numbered in the left margin to facilitate the work of reviewers.

The manuscript will have the structure of a scientific paper divided into the following sections:

Title

Should be written in the document original language and in English, and indicate precisely the theme of work and must not exceed 15 words. Should be written in capital letters respecting the nomenclature of scientific names, centered and in bold.

Author (s).

Put full names in uppercase letters. After one space, put the institutional address, telephone and e-mail of each of the authors. Indicate with an asterisk after the name, which will be the corresponding author.

Summary

It must be written in the same language of the document. It will have a maximum of 200 words. No paragraphs or references.

Key words

Not more than five.

Resumo o Abstract

It Written in Portuguese or English with a maximum of 200 words. No paragraphs or references.

Palavras chaves o Key words:

With not more than five

Text

The text must be separated into: Introduction, Materials and Methods, Results and Discussion, Conclusions, Acknowledgements and References. Scientific names should be written in italics and is acknowledged for the first time the author must be mentioned.

REFERENCES

Must be recorded in alphabetical order and numbered, based on APA writing style, as shown in the following examples:

Tables

It should be developed with Word Processor, without vertical lines and with a minimum of horizontal lines. Should be clear enough to replace text, and therefore should be self-explanatory. The data presented in tables should not be repeated in the text. The tables are placed at the end of the text with the title of the table top. The abbreviations and symbols used in the body of the table, to be explained in the lower part thereof.

Figures

They should be in black and white and processed in Windows 98 compatible programs. The illustrations must be included in *jpg format. Figures and illustrations must be placed at the end of the document, with the title at the bottom.

Color images only will be included in special cases when the color is essential for the description of the information provided. The inclusion of color images have an additional cost will be covered by the author.
